THIS IS THE PRIMARY PROGRAM. NORTHWOODS HABITAT FOR HUMANITY BUILDS AND RENOVATES HOMES UTILIZING VOLUNTEER LABOR, DONATED MATERIALS, AND CONTRIBUTED FUNDS. THE HOMES ARE THEN SOLD WITH A ZERO INTEREST LOAN TO PRE-QUALIFIED, LOWER INCOME FAMILIES. HOMEBUYERS ARE SELECTED BASED UPON NEED, ABILITY TO REPAY THE HABITAT MORTGAGE, AND WILLINGNESS TO PARTNER. THE ORGANIZATION ALSO TITHES A PORTION OF ITS GENERAL DONATIONS TO HABITAT FOR HUMANITY INTERNATIONAL FOR USE IN BUILDING HOMES OUTSIDE THE UNITED STATES.
